I agree that if my dog(s) arrives with fleas and/or ticks, it(they) may be treated with tick/flea preventative at **Pamper Ur Poochie Parlor's** discretion, at my expense.

I further certify that my dog(s) has(have) not harmed or shown aggressive or threatening behavior towards any person or any other dog, except as disclosed under item 7 of this agreement.

I give authorization to **Pamper Ur Poochie Parlor** to speak with my veterinarian and/or their staff to confirm my dog(s) vaccination status, date of surgical alteration, and medical history.

- Pamper Ur Poochie Parlor** is an open play environment and because dogs' pack instincts can at times be unpredictable, there are inherent risks which, even when closely monitored, may result in the following: i) transfer of communicable illness such as, but not limited to, bordetella virus ("kennel cough"), and ii) injuries such as, but not limited to, broken nails, sore pads, abrasions, lacerations, punctures and/or cuts etc.
- Pamper Ur Poochie Parlor** shall not be liable for any injury, illness or damage to any person or persons, animals (including my own pet(s)), or to any property, however caused, which result from the training, behavior, care or grooming of my pet, as well as from any negligence on the part of any other pet owner attending **Pamper Ur Poochie Parlor**.

I further agree that **Pamper Ur Poochie Parlor** shall not be liable for any costs, attorney's fees or expenses incurred in connection with any claim, action or proceeding occurring as a result of my pet's participation at **Pamper Ur Poochie Parlor**.

- Pamper Ur Poochie Parlor** reserves the right to administer aid and/or use any available veterinarian for my pet should the need arise, whether or not **Pamper Ur Poochie Parlor** can reach my emergency contact or me. I will assume full financial responsibility for any and all veterinary expenses incurred, in addition to other fees incurred for services provided at or by **Pamper Ur Poochie Parlor**.

5. I am solely responsible for any harm and/or damage caused by my dog(s) to persons, property or other pets, while my dog(s) is(are) attending **Pamper Ur Poochie Parlor**. Costs for repairs to property will also be my sole responsibility.
6. **Pamper Ur Poochie Parlor** reserves the right to refuse services or admittance to any dog at their discretion.
7. I agree that I have given full disclosure of any history of aggressive behavior by my dog, and understand that failure to do so will result in termination of services from **Pamper Ur Poochie Parlor** and no refund shall be given.
8. My dog's behavior now and in the future is solely my responsibility. Should any behavior on the dog's part now or in the future result in damage to the property, owners, or person of a third party, I agree to assume full liability for any and all such damage, and to absolve **Pamper Ur Poochie Parlor** from any and all obligations to pay such damage.
9. I understand that the hours of operation are 7am to 7pm Monday through Friday, 9am to 5pm Saturdays and 10am to 1pm Sundays. Dogs not picked up by closing will be subject to an additional boarding charge and will be released the next business day, unless arrangements with **Pamper Ur Poochie Parlor** are made to the contrary.
10. Should my pre-approved agent or I fail to contact **Pamper Ur Poochie Parlor** within 48 hours of the arranged pick up time, my dog(s) may be considered to be abandoned. Any expenses incurred for the transport, overnight care, and/or placement or adoption of said pet shall be paid by me in addition to any other fees incurred for services provided by, at, or through **Pamper Ur Poochie Parlor**.
11. I hereby grant a lien on said pet for any and all unpaid charges resulting from services provided by, at, or through **Pamper Ur Poochie Parlor**.
12. I agree that my dog(s) may be videotaped, photographed, and/or recorded. **Pamper Ur Poochie Parlor** shall retain the exclusive rights to the results and all proceeds of such tapings, photograph, and recordings with the rights throughout the world, an unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner.
